Share Buy Back Information

Since March 1995, the Board of Directors has authorized the repurchase of Common Stock in the open market when the shares trade at a discount to net asset value of at least 8%. Through December 31, 2015, the Company has repurchased a total of 22.2 million shares of Common Stock at a total cost of \$637.1 million. During the twelve months ended December 31, 2015, 3,014,364 shares of Common Stock were repurchased at a cost of \$101,674,879, a discount of 15.5% to net asset value.


