**GENERAL AMERICAN INVESTORS COMPANY, INC.  
QUARTERLY DIVIDEND AND DISTRIBUTION ON 5.95% PREFERRED STOCK**

NEW YORK – April 12 – The Board of Directors of General American Investors Company, Inc., a closed-end investment company listed on the New York Stock Exchange (GAM), declared on its 5.95% cumulative preferred stock, series B, a dividend and distribution of \$0.371875 per share payable in cash on June 26, 2017 to holders of record on June 7, 2017. This quarterly dividend and distribution represents a payment for the accrual period from March 24, 2017 through June 25, 2017. Preferred shareholders will be informed in early 2018 of the taxable portions of the distribution.

General American Investors was founded in 1927, has been publicly traded since its inception and has been listed on the NYSE since 1930. The objective of the Company is long-term capital appreciation through investment in companies with above average growth potential. The Company has net assets of approximately \$1.1 billion applicable to its 27.0 million shares of common stock outstanding. The aggregate liquidation value of the Company's preferred stock is \$190 million. Its preferred shares (symbol GAM Pr B) are also listed on the NYSE.
