Share Buy Back Information

Since March 1995, the Board of Directors has authorized the repurchase of Common Stock in the open market when the shares trade at a discount to net asset value of at least 8%. Through December 31, 2016, the Company has repurchased a total of 24.3 million shares of Common Stock at a total cost of \$705.1 million. During the twelve months ended December 31, 2016, 2,149,240 shares of Common Stock were repurchased at a cost of \$67,991,719, a discount of 17.7% to net asset value.


