Share Buy Back Information

Since March 1995, the Board of Directors has authorized the repurchase of Common Stock in the open market when the shares trade at a discount to net asset value of at least 8%. Through March 31, 2021, the Company has repurchased a total of 30.4 million shares of Common Stock at a total cost of \$914.9 million. During the three months ended March 31, 2021, 334,842 shares of Common Stock were repurchased at a cost of \$12,873,118, a discount of 14.9% to net asset value.

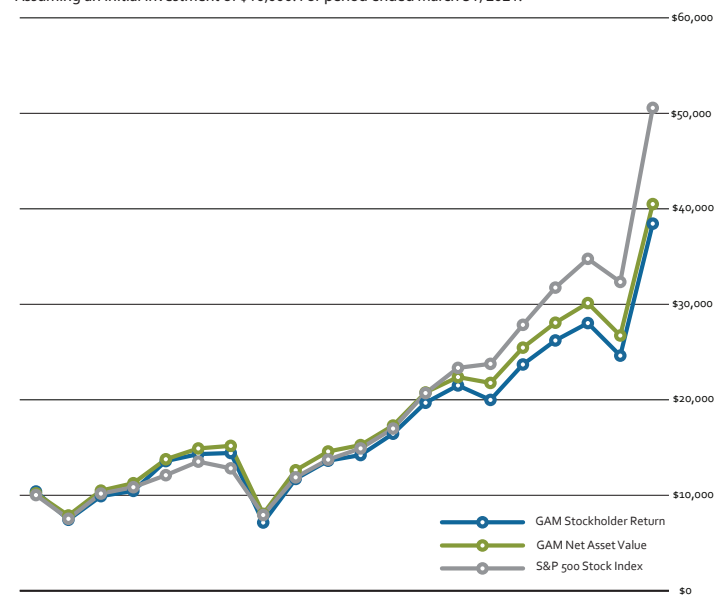
