Share Buy Back Information

Since March 1995, the Board of Directors has authorized the repurchase of Common Stock in the open market when the shares trade at a discount to net asset value of at least 8%. Through September 30, 2023, the Company has repurchased a total of 32.1 million shares of Common Stock at a total cost of \$986.7 million. During the nine months ended September 30, 2023, 456,016 shares of Common Stock were repurchased at a cost of \$18,623,967 a discount of 17.7% to net asset value.


