Share Buy Back Information

Since March 1995, the Board of Directors has authorized the repurchase of Common Stock in the open market when the shares trade at a discount to net asset value of at least 8%. Through December 31, 2024, the Company has repurchased a total of 33.4 million shares of Common Stock at a total cost of \$1.0 billion. During the year ended December 31, 2024, 969,931 shares of Common Stock were repurchased at a cost of \$48,040,986 a discount of 16.0% to net asset value.

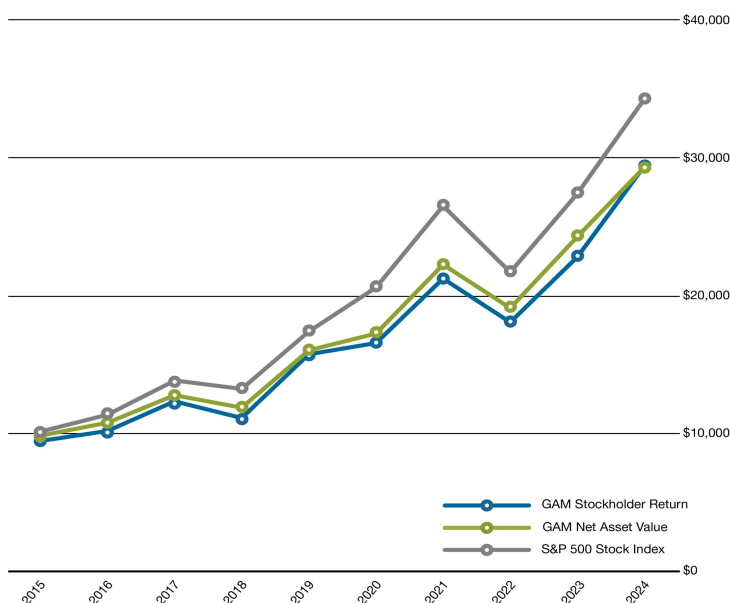
