Share Buy Back Information

Since March 1995, the Board of Directors has authorized the repurchase of Common Stock in the open market when the shares trade at a discount to net asset value of at least 8%. Through June 30, 2021, the Company has repurchased a total of 30.6 million shares of Common Stock at a total cost of \$923.8 million. During the six months ended June 30, 2021, 546,332 shares of Common Stock were repurchased at a cost of \$21,811,523, a discount of 14.6% to net asset value.

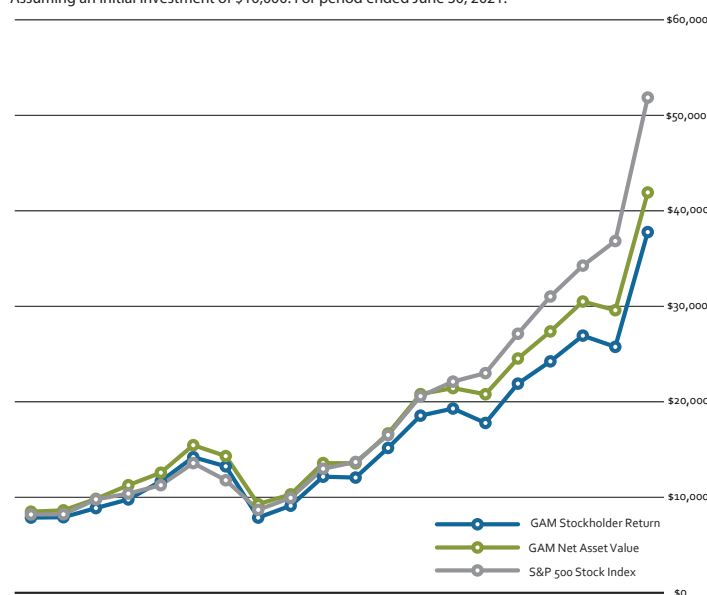
